n adviser to Ukraine's APresident Volodymyr Zelenskyy says that the country won't accept any cease-fire until all the Russian troops pull

Thursday's statement from Mykhailo Podolyak, who was involved in several rounds of talks with Russia, reflects an increasingly confident stand taken by Ukraine as it has fought the Russian offensive to an effective standstill.

"Do not offer us a ceasefire this is impossible without total Russian troops withdrawal," Podolyak wrote on

In a reference to a 2015 peace agreement for eastern Ukraine that was brokered by France and Germany and signed in the Belarusian capital Minsk, Podolyak wrote: "Ukraine is not interested in new 'Minsk' and the war renewal in a few years."

Several Ukrainian officials have recently issued similar statements. Podolyak didn't specify what would constitute "total" withdrawal. He added that "until Russia is ready to fully liberate occupied territo-

ries, our negotiating team is weapons, sanctions and

British military authorities say Russia's centralised command and control structure is likely to come under increasing strain as senior officers seek to avoid responsibility for failures during the invasion of Ukraine.

The UK Ministry of Defence, in a briefing posted on Thursday morning, said a number of senior Russian commanders have already been fired for poor performance during the war.


