# S will work closely with great ally' India:

WASHINGTON

is a 'great ally' and partner" of the US and the administration will work closely with Prime Minister Narendra Modi in a wide range of issues, a senior State Department official said.

State Department spokesperson Morgan Ortugus said that Secretary of State Pompeo was looking forward to have a "robust discussion with his Indian counterpart on a wide range of issues. The Trump administration, including President Trump, Vice President Pence and Pompeo, continued Prime Minister and his Bharatiya Janata Party's victory in the Lok Sabha elections, of course, will work with Modi, as we have

many times," Ortugus told reporters in response to a question during an off-camera news conference on Tuesday.

"We're confident in the fairness and integrity of the elections, and I think that Secretary Pompeo will have a very robust discussion on a range of issues. India is a great ally and partner of the United States," Ortugus said.

Her comment came amid a report that Pompeo may visit New Delhi next month on his way to Osaka, Japan for the G20 summit to be attended by Prime Minister Modi, US President Donald Trump and other leaders.

Meanwhile, US lawmakers and senior government officials continue to congratulate Prime Minister Modi on his electoral victory.
